The Governor, Himachal Pradesh, is pleased to constitute a committee of the following members for selection of prisoners to the Open Air Jail Bilaspur:-

1. District Magistrate of the District where the convict resides. (Chairman)

- 2. Superintendent of Police of the District where the convict resides (Member)
- 3. Superintendent Jail of the District where the prisoner is confined (Member)
- 4. Superintendent Open Air Jail, Bilaspur (Member)

Terms of References: The function of the committee shall be:-

Category of prisoners eligible for admission to the Open Air Jail:

- i. All convicts belonging to Himachal Pradesh and convicts belonging to other than Territories / states at to may be considered, provided that they have shown good conduct in the jail and have not been punished for escape or other serious jail offence.
- All convicts excepting habitual and those convicted for heinous offence, provided that a casual convict has still to undergo an unexpired sentence of at least 4 months at the time of his admission to the Open Air Jail.
- iii. Habitual prisoners, provided they do not have more than one previous conviction except in the case of convicts under Section 109 Cr. P.C, who can be considered eligible even with two previous convictions under the same section viz. 109 Cr. PC.
- iv) Convicts under section 302 IPC (Murder) and 304 IPC (Murder) i.e. (not amounting to murder), provided that such convicts have under gone at least half of their sentence.
- v) Convicts sentenced for forgery and poisoning provided they have completed at least 1/4th of their sentence.

Categories pf prisoners who will not be admitted to the Open Air Jails:-

- Convicts sentenced for dacoity, rape, escapes and other serious jail
 offences as well as those returned by the Open Air Jail authorities
 on disciplinary, medical or other grounds.
- Convicts sentenced under provisions of the special power act or offences connected with political agitation / movements.

All prisoners between 21 and 50 years of age will be considered eligible subject to physical fitness and capacity for hard labour except those having any physical deformity, prays of any infections disease, suffering from mental disequilibrium and having boyish looks will not be selected.

Terms of References: Five years.

- 3. The official member shall be subject to the TA / DA Rules which govern them.
- 4. The existing instructions regarding selection of prisoners to Open Air Jail Bilaspur shall stand sustained with immediate effect.

NOTIFICATION

Subject: Selection of prisoners for admission to the, Open Air Jail, BILASPUR.

In super-session of this Department Notification No. PR – A (5) – 7 / 77 – Part – III dated the 23^{rd} December, 1977, the Governor, Himachal Pradesh, is pleased to order that the following procedure will be adopted henceforth for selecting prisoners for admission to the Open Air Jail, Bilaspur.

(1) The Superintendent of Jail will, in the first instance, forward the cases of the convicts to the District Magistrate of the District to which the convict, belong through the Superintendent of police of that district, subject to the physical fitness and willingness of the eligible convicts for admission to the Open Air Jail, viz if they work properly, they would not only earn wages but also earn special remissions. The Superintendent of Police of the district to which the convict belongs will then collect the report of the Police functionaries within ten days after the receipt of the case from the Superintendent Jail and will forward the same to the District Magistrate concerned after recording his specific recommendations. The District Magistrate will then recommend these cases to the Inspector General of Prisons who will make the final selection of the prisoners to Open Air Jail. The Inspector General of Prisons may as a special case, select any prisoner who does not satisfy the prescribed conditions for reasons to be recorded in writing by him. The Superintendent of Jail may also submit separately the cases of the prisoners, who though do not satisfy the prescribed conditions but in his opinion are suitable for employment in the Camp.

- (2) Categories of prisoners eligible for admission to the Open Air Jail:
 - a) All convicts belonging to Himachal Pradesh and convicts belonging to other Union Territories / States etc. may be considered, provided that they have shown good conduct in the Jail and have not been punished for escapes or other serious Jail offences.
 - b) All convicts excepting habitual and those convicted for heinous offences, provided that a casual convict has still to undergo an unexpired sentence of at least 4 months at the time of his admission to the Open Air Jail.
 - c) Habitual prisoners, provided they do not have more than one previous conviction except in the case of convicts under section 109 CPC, who can be considered eligible even with two previous convictions under the same section viz. 109 Cr. P.C.
 - d) Convicts under section 302 I.P.C (Murder) and 304 I.P.C (Homicide not amounting to murder), provided that such convicts have undergone atleast eight years of their sentence including remissions.
 - e) Convicts sentenced for forgery and poisoning provided they have completed atleast 1/4th of their sentence.
- (3). Categories of prisoners who will not be admitted the Open Air Jail:
 - a) Convicts sentenced for decoity, rape, escape and other serious Jail offences as well as those returned by the Open Air Jail authorities on disciplinary, medical or other grounds.
 - b) Convicts sentenced under provisions of the Special Power Act. Or offences connected with political agitation / movements.

For existing para (2) (d) of the procedure, the following shall be substituted:-

Convicts under Section 302 IPC (Murder) and 304 IPC / Homicide not amounting to Murder), provided that such convicts have undergone at least eight years of their sentence including remission.

The condition of eight years will be in the cases of convicts who have been sentenced to life imprisonment under the provision of the aforesaid sections, whereas the convicts sentenced to undergo lesser term of imprisonment under this sections should have completed at least four years of imprisonment including remissions.
