**NOTIFICATION**

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor, Himachal Pradesh, in pursuance to the Department of Personnel's instructions issued vide letter No. PER(AP)-C-A(3)-5-2013-II dated 12.08.2022 and 16.08.2022, issued in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the following Rules further to amend the Himachal Pradesh Prisons and Correctional Services Department, Assistant Superintendent Jail/Welfare Officer-cum-Assistant Superintendent Jail, Class-III (Non-Gazetted) Recruitment and Promotion Rules, 2020 notified vide this Department Notification No. Home-C (B) 2-6/2016-Jails dated 29.12.2020, namely:-

Short title and commencement.	1	(i) These Rules may be called the Himachal Pradesh Department of Prisons and Correctional Services, Assistant Superintendent Jail/Welfare Officer-cum-Assistant Superintendent Jail, Class-III (Non-Gazetted), Recruitment and Promotion Rules (1 <sup>st</sup> amendment), 2022. (ii) These rules shall come into force from the date of their publication in the Rajpatra (e-Gazette), Himachal Pradesh.
Amendment of Annexure: A.	2	In Annexure "A" appended to the Himachal Pradesh Prisons and Correctional Services Department, Assistant Superintendent Jail/Welfare Officer-cum-Assistant Superintendent Jail, Class-III (Non-Gazetted) Recruitment and Promotion Rules, 2020 (herein after referred as the said Rules),- Amendment in Column No.4. (a) For the existing provision against Column No.4, the following shall be substituted, namely:- (i) <u>Pay Scale for regular incumbent(s)</u> : Rs. 38,100-1,20,400/ "Level 10 of the pay matrix attached with time scale of the post, as Per H.P. Civil Services (Revised Pay) Rules, 2022". (ii) <u>Emoluments for contract employee(s)</u> : Rs.22,800/P.M. as per details given in Column No.15-A. "60% of the first cell of the applicable level of pay matrix of the corresponding cadre, as per H.P. Civil Services (Revised Pay) Rules, 2022." Amendment in Column No. 15. (b) For the existing provision against Column No.15, the following shall be substituted, namely:- "Selection for appointment to the post in the case of direct recruitment shall be made on the basis of merit of written examination and/ or practical test or skill test or physical test, the standard/ syllabus etc. will be determined by the Himachal Pradesh Public Service Commission/Himachal Pradesh Staff Selection Commission Hamirpur/other recruiting agency/ authority, as the case may be."

Amendment of Appendix-II.	3	<p>In Appendix-II appended to the said Rules, for serial No.2, the following shall be substituted, namely:-  "2. The contractual amount of the FIRST PARTY will be ₹ 22,860/ per month (which shall be 60% of the first cell of the applicable level of pay matrix of the corresponding cadre)".</p>


