प्रकाश ऐमान्स प्रदेश के राज्यपाल, भारत के संविधान के अनुकूल 309 के परन्तुकु<sup>(८४)</sup> शोक्तये का प्रयोग करते हुए गोरे ऐमान्स प्रदेश दोके सेवा आशोग से परम्परा करने के पश्चात ऐमान्स प्रदेश के कारागार विभाग में, अधीक्षक, (छुआ कारागार) बिलासपुर एवं अधीक्षक कारागार (वर्ग 11) (राजनीति) के पदों की वाचन वार्धिक्यवना सं० फूले 14-929/58 वारेखा 15 अक्टूबर, 1969 के साथा ओर्डर्सूचित और समय सम्म पर यथा- रंशोधन भर्ती और पदोन्नति नियमों में संशोधन करने के तिर निम्नलिखित नियम बनाते हैं अर्थात् :-

Short title and commencement

- 1(1) These rules may be called the Bihar Prisons Department Class-II (Gazetted) Services (Recruitment Promotion and certain conditions of Service) for the posts of Superintendent, Open Air Jail, Bilaspur/Deputy Superintendent Jail, Class-II (Gazetted) (1st amendment) Rules, 1984.
- (2) These shall come into force with immediate effect.

Amendments to Annexure A 2. For the existing entries of Col. 4 & 11 of Annexure 'A' of the Recruitment Rules for the posts of Superintendent, Open Air Jail and Deputy Superintendent Jails, Class-II (Gazetted), the entry in Col. 4 & 11 shall be substituted namely:-

Col. No.4

Rs. 750-1300

Col. No.11

i) Welfare Officer in the scale of Rs. 620-1200 (with 3 years service in the grade);

ii) Assistant Superintendent Jails in the scale of Rs. 620-1200 (with 3 years service in the grade).

(The promotion is to be based on joint seniority lists prepared on the basis of length of service in the grade).

3. After Col. No.13 Annexure 'A' of the aforesaid rules,

the following Col. 14 shall be substituted, namely:-

Power to relax Where the Government is of the opinion that

It is necessary or expedient to do so in the public interest, it may, by order for reasons to be record in writing and in consultation with the I.P.P.S.C., make any of the provisions of these rules with respect of any class or category or person or post.

4. In the end of the Annexure 'A' of the aforesaid rules, the following foot-notes shall be inserted, namely:-

**Foot-note:-** 1. A candidate for appointment to any service or post must be:-

- a) a Citizen of India, or
- b) a subject to Nepal, or
- c) a subject to Bhutan, or
- d) Tibetan refugees who came over to India before the 1st January, 1962 with the intention of permanently settling in India, or
- e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (Formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire and Ethiopia with the intention of permanently settling in India.

Provided that a candidate belonging to categories (b), (c), (d) and (e) shall be person in whose favour a certificate of eligibility has been issued by the Government of India/State Govt.

A candidate in whose case a certificate of eligibility is necessary may be admitted to an examination or interview conducted by the I.P.P.S.C. or other recruiting authority, but the offer of appointment may be given on after the necessary eligibility certificate has been issued to him by the Government of India/Govt. of H.P.

2. Upper age limit is relaxable for Scheduled castes/Tribes candidates and other categories of persons to the extent permissible under the general or special order of the H.P. Government.

3. Provision of columns 10 and 11 are to be revised by the Government in consultation with the Commission as and when the number of posts under column 2, are increased or decreased.

4. Selection for appointment to these posts in the case of direct recruitment, shall be made on the basis of viva voce test, if the Commission so considers necessary or expedient by a written test or a practical test, the standard/syllabus etc. of which will be determined by the Commission.

5. In all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including ad-hoc ones) in the feeder post, all persons senior to him in the respective category shall be deemed to be eligible for consideration and placed above the junior persons in the field of consideration.

Provided that all incumbents to be considered for probation confirmation shall possess the minimum qualifying service of six to three years or that prescribed in the relevant recruitment and promotion rules for the post whichever is less.

Provided further that where a person becomes eligible to be considered for promotion/confirmation, on account of the requirement prescribed in the preceding proviso the person(s) junior to him shall also be deemed to be ineligible for consideration for such promotion/confirmation.

6. The appointments to this service shall be subject to orders regarding reservation in the services for Scheduled Castes/Scheduled Tribes/Backward classes issued by the H.P.Govt. from time to time.

#### 7. Departmental Examination:

i) Every member of the service shall pass a Departmental examination as prescribed in the Departmental Examination Rules within the probation period or within two years from the notification of these rules whichever is latter failing which he shall not be eligible to:-

- {a} Cross the Efficiency Bar next due;
- {b} Confirmation in the services, and
- (c) Promotion to the next higher post.

Provided that if a member becomes otherwise eligible for promotion, within the period mentioned above, he shall be considered for promotion and if otherwise found fit, shall be promoted provisionally subject to his passing the departmental examination. He may be reverted if he fails to pass the same.

Provided further that an Officer who has qualified the Departmental examination in whole or in part prescribed under any other rules before the notification of these rules, shall not be required to qualify the whole or in part of the examination as the case may be.

Provided further that an Officer for whom no departmental examination was prescribed prior to the notification of these rules and who has attained the age of 45 years on the 1st March, 1976 shall not be required to qualify the departmental examination prescribed under these rules.

(ii) An Officer on promotion to a higher post in his direct line of promotion shall not be required to pass the aforesaid examination, if he has already passed the same in the lower Gazetted

(iii) ... may, in consultation with the Himachal Pradesh Public Service Commission, in exceptional circumstances and for reasons to be reduced to writing in accordance with the departmental examination rules, to any category of persons from the departmental examination in whole or
