NOTIFICATION

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor, Himachal Pradesh, in pursuance to the Department of Personnel's instructions issued vide letter No. PER(AP)-C-A(3)-5/2013-II dated 12.08.2022 and 16.08.2022, issued in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the following Rules further to amend the Himachal Pradesh Prisons and Correctional Services Department, Head Warder, Class-III (Non-Gazetted) Recruitment and Promotion Rules, 2002 notified vide this Department Notification No. Home-B (B) 2-4/94-Jails dated 24-04-2002, namely:-

Short title and commencement.	1	(i) These Rules may be called the Himachal Pradesh Department of Prisons and Correctional Services, Head Warder, Class-III (Non-Gazetted), Recruitment and Promotion Rules (1 st amendment), 2022. (ii) These rules shall come into force from the date of their publication in the Rajpatra (e-Gazette), Himachal Pradesh.
Amendment of Annexure: A.	2	In Annexure "A" appended to the Himachal Pradesh Prisons and Correctional Services Department, Head Warder, Class-III (non-Gazetted) Recruitment and Promotion Rules, 2002 (herein after referred as the said Rules). Amendment in Column No.4. (a) For the existing provision against Column No.4, the following shall be substituted, namely:- (i) <u>Pay Scale for regular incumbent(s) :</u> Rs.25,600-81,200/ "Level 6 of the pay matrix attached with time scale of the post, as Per H.P. Civil Services (Revised Pay) Rules, 2022".
