Procedure for recruitment of Warder (Male and Female) in the Department of Prisons & Correctional Services, Himachal Pradesh:

7.3 Written Test(Maximum 100 Marks):- Written test will be held at a place fixed by the Recruitment Board/ Committee, which will be of 100 marks of objective type of 100 minutes duration. It will include the following sub groups:

a)	English Language	20 questions	
b)	Hindi Language	20 questions	
c)	General Awareness	20 questions	at the state of th
d)	Math's & Science	20 questions	
e)	Reasoning Aptitude	20 questions	

The syllabus for the above written examination shall be of 10+2 standard except Mathematics for which syllabus shall be of Mauriculation standard.

Only such candidates shall be deemed to have qualified who secure 50% marks in the written test in case of those belonging to General/OBC categories and 40% marks in the case of those belonging to Scheduled Casts and Scheduled Tribes categories.

8. The final result will be the sum total of marks obtained in the Written Test (100 marks).
