## NOTIFICATION

In exercise of the powers conferred by provisio to Article 309 of the Constitution of India, the Governor of Himachal Pradesh in consultation with the H.P. Public Service Commission, is pleased to make the Recruitment and Promotion Rules for the post of Factory Supervisor (Class-III Non-Gazetted) in the Department of Prisons, Himachal Predects as per Americae is attached to this Notification, namily to

Short title and commencement.

- 1. (1) These Rules may be called the Himachal Pradesh Prisons: Department, Factory Supervisor (Class-III Non-Gazetted) Recruitment and Promotion Rules, 200%.
  - (2) These Rules shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.

Repeal and Savings

- 2. (1) The Himachal Pradesh Jails Department Class-III Subordinate (non-Gazetted) Service (Recruitment, Promotion and certain Conditions of Service) Rules, 1967, notified vide notification No. H(J) 14-929/58-II dated 27/11/1967 are hereby repealed to the extent these are applicable to the post of Factory Supervisor.
  - (2) Notwithstanding such repeal, any appointment made or any--thing done or any action taken under the rules so repealed vide Rule 2(1) Supra,

shall be deemed to have validity made, done or taken under these rules.

11. In case of recruitment by : By promotion from amongst the promotion, deputation, transfer, grade from which promotion/deputation/ transfer is to be made.

(1) In all cases of promotion, the continuous adhoc service rendered in the feeder post upto 31/3/98, if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these Rules for promotion subject to the condition that the adhoc appointment/promotion in the feeder category had been made after following proper acceptable process of selection in accordance with the provision of R&P Rules, provided that :-

in all cases where a Junior person becomes eligible for consideration by virtue of his total length of service (including the service rendered on adhoc basis upto 31/3/98) followed by regular service/appointment in the feeder post in view of the provisions referred to above, all persons senior to him in the respective category/post/cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration;

provided that all incumbents to be considered for promotion shall possess the minimum qualifying service of at least three years or that prescribed in the Recruitment and Promotions Rules for the post, whichever is less;

provided further that where a person becomes ineligible to be considered for promotion on account of the requirements of the preceding proviso, the person (s) junior to him shall also be deemed to be ineligible for consideration for such promotion.

Explanation:-

The last provision shall not render the junior incumbents ineligible for consideration for promotion if the senior ineligible

persons happened to be Ex-serviceman recruited under the provisions of Rule 3 of Demobilised Armed Forces Personnel (Reservation of Vacancies in Himachal State Non-Tecnical Services) Rules, 1972 and having been given; the benefit of seniority thereunder or recruited under the provisions of Rule 3 of Ex-serviceman (Reservation of Vacancies in the Himachal Pradesh Technical Services) Rules, 1985 and having been given the benefit of seniority thereunder.

(2) Similarly, in all cases of confirmation, adhoc service rendered on the feeder post upto 31/3/98, if any, prior to the regular appointment against such post shall be taken into account towards the length of service if the adhoc appointment/promotion had been made after proper selection and in accordance with the provision of R&P Rules,

provided that inter-se-seniority as a result of confirmation after taking into account, adhoc service rendered upto 31/3/98 as referred to above shall remain unchanged.

- 12. If a Departmental Promotion Committee exists, what is its composition.
- : As may be constituted by the Govt. form time to time.
- 13. Circumstances under which: As required under the law. the H.P.P.S.C. is to be consulted in making recruitment.
- 14. Essential requirement : Not applicable. for a direct recruitment.
- 15. Selection for appointment: Not applicable.

- 16. Reservation.

- : The appointment to the service shall be subject to orders regarding reservation in the service for Scheduled castes/Scheduled Tribes/Backward Classes/other categories of persons issued by the Himachal Pradesh Govt. from time to time.
- 17. Powers to Relax.
- : Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order for

reasons to be recorded in writing and in consultation with the H.P.P.S.C., relax any of the provisions of these Rules with respect to any class or category of persons or posts.
